When you visit our website, we collect:

- Standard web analytics (via third-party tools)
- Information you submit via contact forms or email

We process this data solely for responding to inquiries and improving our website. Optional cookies are only set with your consent.

Legal Basis for Processing

- Article 6(1)(a) UK GDPR consent (for non-essential cookies).
- Article 6(1)(f) UK GDPR legitimate interests in managing inquiries and website improvements.

8. Marketing Data

We collect and use personal data for marketing communications with individuals who have expressed interest in our services.

How We Collect Data:

- Direct interactions (e.g., service enquiries)
- Third-party referrals
- When you choose to receive marketing communications from us

How We Use Data:

- To send relevant updates about our services
- To manage marketing preferences
